

Schedule 2 – User Terms

- **Licensed Work** – *populated by user selection* excluding embedded content, such as text, figures, tables, illustrations, that is credited to someone other than the author of the Licensed Work.
- **Your Nominated Purpose** – *populated by user selection*
- **Licence Fee** – *calculated by user selection*
- **Additional Terms** – *populated by publisher*

1. Permission

On payment in full of the Licence Fee and subject to the restrictions and obligations imposed by these terms (the User Terms), Copyright Agency Limited (Copyright Agency) as agent for the Publisher grants you a non-exclusive, non-transferable, one time licence to use the Licensed Work for your Nominated Purpose. This licence does not extend to subsequent or revised editions of your use as stated in your Nominated Purpose.

2. Your Obligations

You agree and acknowledge that:

- (a) you will not use, publish, communicate or distribute the Licensed Work except as permitted by these User Terms or with the prior written permission of Copyright Agency;

- (b) Copyright Agency warrants that it is authorised to grant the permission in clause 1 of these User Terms and that your use of the Licensed Work for Your Nominated Purpose will not infringe the copyright in that Licensed Work. To the maximum extent permitted by relevant laws, Copyright Agency expressly excludes any liability for breach of any implied or express warranty of as to merchantability or fitness for a particular purpose of the Licensed Work.
- (c) You acknowledge that neither Copyright Agency nor the Publisher shall be liable:

5. Governing Law, Severance, Waiver

This agreement shall be construed in accordance with the laws of the State of New South Wales and within the jurisdiction of the New South Wales courts. Should any part of this agreement be or become invalid, that part at the option of Copyright Agency shall be severed from this agreement without affecting the validity of the remaining provisions. No delay or indulgence by Copyright Agency in enforcing this agreement shall prejudice its rights.

6. Acceptance of Terms by Use

Use of the Licensed Work indicates acceptance of the terms and conditions of these User Terms by you and your willingness to be bound by them. Copyright Agency hereby rejects and objects to any terms contained in a purchase order, email, invoice or other document submitted by you to the extent those terms are inconsistent with these User Terms.

7. Assignment

You may not assign this agreement or any part thereof without prior written consent of Copyright Agency, which may be given or refused at its absolute discretion.

8. Rates and prices

Unless otherwise agreed by Copyright Agency in writing the price/rates for this licence are exclusive of any taxes, import duties or other levies imposed on the sale or import of this transaction, which shall be charged by Copyright Agency as appropriate.

9. Intellectual property
